A Preferential Point system shall apply whereby a contract will be allocated to a bidder in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Thembisile Hani Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Preferential Procurement Regulation 2017,9 (1-2) on the sub-contracting as a condition of tender must be adhered to a minimum on 30% on the value of projects above R30 million and the tenders will be evaluated in terms of Local content where applicable.
